# CUMRU TOWNSHIP BOARD OF COMMISSIONERS REGULAR MEETING JUNE 19, 2018

The Regular Meeting of the Cumru Township Board of Commissioners was called to order by President Ruth O'Leary at 7:05 p.m. Other Commissioners in attendance were Vice President Edward L. Gottschall, Sheri Hoover, David Batdorf and William B Miller. Also attending were Superintendent of Public Works Robert McNichols, Jr., Assistant Superintendent of Public Works Michael L. Yost, Manager Jeanne E. Johnston, Secretary Latoya Procopio, and Joseph P. Rogosky of Great Valley Consultants.

## B) Elizabeth Aulenbach re: 180 Candy Rd.

Ms. Elizabeth Aulenbach of 178 Chateau Drive was present for discussion. Ms. Aulenbach stated she was representing herself and her neighbors regarding the property at 180 Candy Road. She stated the property was bought in 2016 and since then they have had issues. The owner of the property, the Old Catholic Confederation, calls it the St. Willibrord Priory. Ms. Aulenbach gave details from the St. Willibrord Priory website; she stated that members have special privileges such as retreats, sabbaticals, and gift shop. The website states that this is the business headquarters. Ms. Aulenbach expressed her concern that this residential home may be violating the zoning ordinance. She does not agree with their tax exempt status.

Ms. Aulenbach claimed St. Willibrord Priory cut down a few trees that were on her property and encouraged parking on private property during an event. When a resident confronted the constable that was hired to manage parking, he refused to move the parked vehicles. The police were then called.

Mr. Setley stated there are 3 different issues at hand. Priory conduct such as obstructing access to other properties can be addressed by the police, when called. Cumru Township will investigate the potential zoning issues. The third issue is the Priory's tax exemption, which is not Cumru Township's call. Mr. Setley stated tax exemptions are governed by the Berks County office.

Mr. Myles O'Conner of 4 Tudor Court was also present for discussion. He stated that he agreed with all that Ms. Aulenbach had stated previously.

#### C) Jose Ortiz re: deer

Mr. Jose Ortiz of 845 Madison Street was present for discussion. Mr. Ortiz stated he was concerned with the number of deer in his yard. He stated that he has contracted Lyme disease on 5 different occasions. He believes that the deer coming through his yard contributed to his illness and that they also create issues with traffic. He stated that he was instructed to build a fence around his property, but that would be expensive. He stated he will take down his apple
