CUMRU TOWNSHIP BOARD OF COMMISSIONERS SPECIAL MEETING NOVEMBER 29, 2023

The Special Meeting of the Cumru Township Board of Commissioners was called to order by President Ruth A. O'Leary at 5:00 p.m. Other Commissioners in attendance were Vice President David J. Batdorf, Sam Kalbach, William B. Miller and Lisha Rowe. Also attending were Solicitor Kelsey Frankowski, Chief of Police Madison Winchester, Superintendent of Public Works Robert McNichols, Jr., Asst. Superintendent of Public Works Michael Yost, Jr., Manager/Secretary Jeanne E. Johnston, Business/Personnel Administrator Peggy A. Carpenter, and Special Projects/Asst. Secretary Patricia A. Wylezik-Pfeiffer. Fire Chief James Beane and Joseph P. Rogosky of Great Valley Consultants were excused.

A.) Joe D'Ascenzo – Request for a letter of support for DCED grant applications for Refined Plastics.

Joe D'Ascenzo addressed the Board to request a letter of support and ask Cumru Township to function as a pass through agent for the DCED grants applications for Refined Plastics.

There was discussion about the grant guidelines and the information required to draft a resolution. Mr. D'Ascenzo explained that they are applying for two different grants; one for equipment in the amount of approximately \$903,000 and another for in the amount of approximately \$854,000 for engineering/planning for a building, new railroad tracks and a bridge over the railroad tracks.

Atty. Frankowski and Ms. Johnston both stated that the Township would need exact amounts and detailed scopes of the projects for the resolutions. Atty. Frankowski confirmed that a separate resolution would be needed for each grant application. Mr. D'Ascenzo stated that the resolutions were not required at the time of grant submission. He only needs the letter of support at this time.

Ms. Johnston reminded Mr. D'Ascenzo that the Township would not own or assume any responsibility for the proposed bridge. Mr. D'Ascenzo acknowledged that his company would own and maintain the bridge since it is on his property.

Mr. D'Ascenzo stated that the Township could receive 2 % in administrative fees from these grants.

Mr. Donnell, a newly elected Cumru Commissioner, stated that he thought that the Board should wait to decide on this request until the new Board takes office.

The Board informed him that the deadline to apply for the grants is November 30, 2023, so the Commissioners needed to decide at this meeting.

ON MOTION OF MR. MILLER, SECOND OF MR. KALBACH, A UNANIMOUS VOTE TO APPROVE A LETTER OF GENERAL SUPPORT FOR THE DCED GRANTS FOR REFINED PLASTICS.

B.) Andrew Donnell, a resident of Nassau Circle, had indicated on the sign-in sheet that he wished to speak. He planned to talk about the Titus Substation. Mr. Donnell said that he is not opposed to development but given the timing and the circumstances, he asked the Board to defer consequential decisions until the Board reconvenes in January.
