CUMRU TOWNSHIP BOARD OF COMMISSIONERS SPECIAL MEETING JUNE 29, 2021

The Special Meeting of the Cumru Township Board of Commissioners was called to order by President William B. Miller at 7:00 p.m. Other Commissioners in attendance were Vice President Ruth A. O'Leary, David J. Batdorf, Chip Bilger, and Sam Kalbach. Also attending were Solicitor Michael A. Setley, Chief of Police Madison Winchester, Fire Chief James A. Beane, Superintendent of Public Works Robert McNichols, Jr., Business/Personnel Administrator Peggy A. Carpenter, Manager/Secretary Jeanne E. Johnston, Assistant Secretary/Special Projects Patricia Wylezik-Pfeiffer, and Joseph P. Rogosky of Great Valley Consultants.

This meeting is being recorded for the purpose of assisting in the preparation of meeting minutes. The audio file of the meeting will be destroyed after official meeting minutes for this meeting have been adopted.

PRESENTATIONS

A) Herbein+Co. re: FY 2020 Audit Summary

Nick Beiber of Herbein+Co. presented the 2020 financial statement. There were no findings.

PUBLIC

A) Michael and Greta Guigley re: Eshelman Lane

Greta Guigley of 100 Eshelman Lane asked about limits on the number of homes allowed on a shared driveway. She indicated that she and her husband were concerned about a new home to be built on Eshelman Lane, a shared driveway. Mr. Setley stated that the lot in question was approved and recorded, which allowed use of that access. Ms. Johnston informed the Board that the lot in question was subdivided in 1984.

Mrs. Guigley claimed that her father was told in the past that the lane would have to be improved for additional subdivision. The Guigleys want the new lot owner to improve the lane. Mr. Setley stated that regulations had changed since 1984, but the previous action can't be undone.

Mrs. Guigley said she and her husband want to subdivide. Ms. Johnston stated current regulations limit the number of homes on a shared driveway to three. Mr. Setley noted that there have occasionally been waivers to that number. Ms. Johnston stated that the current ordinance requires a shared driveway agreement. With respect to possible future subdivision, Mr. Setley encouraged the Guigleys to get permission from the existing neighbors for a shared driveway agreement.

Ms. Johnston informed the Board that the 2022 budget would have to address funding obligations for the Wyomissing Creek TMDL plan that has now been approved. That obligation is \$400,000 over the next 5 years. Such funds can be expensed from the ARP money.

The Board indicated that the present year budget should be revised to take into account allowable expenses for water, stormwater, and sewer projects. With respect to the developer request for ARP funds, it is anticipated that Township projects, including the Wyomissing Creek and the campus utility project, will consume the ARP funds. Mr. Setley suggested that the developer be referred to Berks County since the County is considering requests from businesses for ARP funds.
