ORDINANCE NO. 767

AN ORDINANCE OF THE TOWNSHIP OF CUMRU, COUNTY OF BERKS, COMMONWEALTH OF PENNSYLVANIA ESTABLISHING THE SEWER RATES FOR BUILDINGS CONNECTED TO THE SANITARY SEWER SYSTEM OF THE TOWNSHIP

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Cumru, County of Berks, Commonwealth of Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

SECTION 1. The Basic Rate per Equivalent Dwelling Unit ("EDU") to be charged for sanitary sewer billing purposes within the Township is established, effective with the second billing period of 2021, as follows:

- A. For each Building connected to public water:
 - 1. The Basic Rate shall be One Hundred Twenty-Five Dollars (\$125.00) for the first 7,500 gallons of water consumed, as reflected by the water meter reading, for each quarter; and
 - 2. One and Sixty-Seven Hundredths Cents (\$0.0167) per gallon for each gallon over 7,500 gallons per quarter.
- B. For each Building obtaining their water form on-site wells, and not connected to a public water system, the flat Basic Rate per quarter shall be One Hundred Seventy-Four Dollars (\$174.00)

SECTION 2. For all purposes hereof, the term "Building" shall mean and include any structure having a roof or other covering and designed, used or intended for supporting or sheltering any use or occupancy. Each portion of a building which is completely separated for occupancy or dwelling purposes from other portions by fire walls, dividing walls or any other type of wall or separation structure shall be considered as a separate building. Any buildings on a single lot with laterals that combine into one connection to the sewer are treated as separate buildings with separate connections.

SECTION 3. This Ordinance shall take effect on the first date permitted by law.

SECTION 4. If any provision, sentence, clause, section or part of this ordinance shall for any reason be found unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this ordinance and it is hereby declared to be the intent of the Township Board of Commissioners that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part not been included herein.

SECTION 5. All ordinances or parts of ordinances and all existing portions of the Code of the Township of Cumru inconsistent herewith are hereby repealed.
